

Advocacy Toolkit:

Individual Patient Treatment Requests (IPTRs) — Scotland

What are they?

Individual patient treatment requests (IPTRs) are the NHS Scotland procedure for an individual to gain access to funding for services or treatments not routinely provided by the NHS.

An IPTR will be required to access a treatment in the following circumstances:

- The Scottish Medicines Consortium (SMC) or NHS Healthcare Improvement Scotland (HIS) have appraised the treatment and given the advice of 'not recommended' for treatment of the patient's condition.
- The treatment is relatively new and has not yet been assessed by the SMC or NHIS.

The process

In Scotland, IPTRs are managed by individual Health Boards and each has developed their own policy. In some instances, reviews of IPTRs are undergoing and it appears they may be replaced by PACS (Peer Approved Clinical Systems). This is currently the process for clinicians to gain access to 'not recommended' drugs for the treatment of very rare disorders (ultra-orphan drugs).
